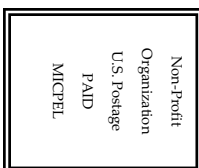

ABOUT THE PROGRAM:

The expanded jurisdiction of the District Court, combined with the crowded Circuit Court dockets have made the District Court a more efficient, economical and attractive venue for the resolution of an increasing number of serious cases in the personal injury, landlord/tenant, commercial and domestic violence areas. The increased benefit of taking many cases to District Court is obvious – the demands on the lawyer, however, are also greater. The District Court is not a place to “wing it.” Despite the perceived relaxed atmosphere, special skills are required to effectively manage and present a case within the confines of limited discovery and motions practice, and especially the limited budget and time constraints of a District Court case.
