# MD Court of Appeals Accepts Recommendation to Adopt Uniform Bar Exam

#### By Maryland Judiciary

The Maryland Court of Appeals at its Conference on November 16, 2017, voted unanimously to accept the recommendation of the Advisory Committee to Explore the Feasibility of Maryland's Adoption of the Uniform Bar Examination (UBE) to adopt the UBE, along with a Maryland law supplement to the examination, to be implemented in 2019.

The Advisory Committee, comprised of judges, law school deans, attorneys from small and large firms, members of the State Board of Law Examiners, and others, studied the potential benefits and disadvantages of adoption of the UBE in lieu of the traditional Maryland bar examination, and concluded that "the benefits of a uniform, portable, exam were significant and outweighed all disadvantages . . . [.]" In September,

the Court of Appeals received the Advisory Committee's report and recommendations and thereafter received public comments for a 30-day period.

"I am pleased with the Court's decision to consider carefully and accept the Committee's recommendation to adopt the Uniform Bar Examination," said Maryland Court of Appeals Judge Sally D. Adkins, Chair of the Advisory Committee. "The Advisory Committee is research helped the Court to determine that, in adopting the Uniform Bar Examination, Maryland bar applicants would continue to be required to pass an examination of sufficient rigor that assures their competency to practice law."

"The Court is grateful for the Advisory Committee's diligence in examining this issue," said Mary Ellen Barbera, Chief Judge of the Maryland Court of Appeals. "The Uniform Bar Examination, along with the Maryland law component, will assure that applicants possess the knowledge and skills necessary to practice law in Maryland, plus afford those who pass the exam the portability of transferring their results to other jurisdictions that have also adopted the Uniform Bar Examination."

The Court of Appeals will form a committee to address the subject matter and format of the Maryland component of the UBE and other aspects of implementation of the UBE. The Advisory Committee's report is available on the Maryland Judiciary website (http://mdcourts.gov/coappeals/ube/pdfs/ubeadvisoryreport.pdf). # 2018 MSBA Legislative Preview

#### By Richard A. Montgomery III

#### Introduction

Just let Maryland go on being Maryland. That is my one wish for the 2018 Maryland General Assembly session. That's it.

More than I've ever seen, daily reports concerning federal government activity seem to range from extreme drama and near-chaos. Currently (as of this writing), there are rapidly changing measures before both chambers of Congress proposing tax reform or tax cuts, depending upon who's speaking, and hints of yet another pass at health care reform. And then there's perhaps the most controversial proposed Executive administrative action in recent memory - with the rescission of the FCC's "net neutrality" rules, moving closer to becoming reality.

As a result, state and local governments across the nation must be prepared to respond nimbly, yet decisively in cases where functionally non-preemptive federal policies differ dramatically from policies and goals of the respective states and locales. Such an endeavor is somewhat more complicated in states like Maryland where there is a "citizen" (as opposed to a full-time) legislature.

To ensure our members are appraised in realtime about the status of legislative activity, MSBA will move to a new legislative tracking and reporting platform, TrackBill, which will provide up-to-theminute bill status information on all bills the MSBA is acting upon. That information will be available on a new Legislative Activity Center on the MSBA website.

Despite the simultaneous turmoil/gridlock on Capitol Hill, and the fact that 2018 is an election year, I have the utmost confidence that the Maryland General Assembly remained focused on the policy matters at-hand and have a productive Session.

#### Election 2018

In 2018, not only are the Governor, Attorney General, Comptroller, and the entire General Assembly up for election, next year will mark the most closely watched Congressional mid-term

election for quite some time.

As of this writing, the fields for each of the statewide offices are reasonably manageable. In fact, it is so early that many certain candidates have not filed for their intended offices. The General Election will be held on November 8, 2018.

#### Governor

Republican

Not surprisingly, given his high job approval ratings throughout his term, Governor Larry Hogan will not have a primary election challenger. In fact, at one point during the summer of 2017, Gov. Hogan had the 2nd highest approval rating of any governor in the nation (62% overall, 82% among Republicans), behind Gov. Charlie Baker of Massachusetts. Oddly, Baker is also a Republican governor in a heavily Democratic state.

Interestingly, in the September 2017 Goucher College poll that found that Governor Hogan held an 82% approval rating among Maryland Republicans, 20% of those Republicans polled felt that Governor Hogan was "putting too much distance" between himself and President Trump. Yet, one could deduce that it is that very distance that has preserved the Governor's favorable ratings among non-Republicans polled.

### MSBA President's Letter

December 15, 2017

Dear MSBA Members:

On January 10, 2018, the 438th Session of the Maryland General Assembly will convene. While 2018 is an election year, the Legislature has no shortage of pressing matters in Annapolis to keep their attention.

The Legislature will return with a more positive budgetary forecast than in many years. However, there remains a projected structural operating budget deficit that will force difficult choices in providing services to the citizens of Maryland. Additionally, any changes in federal funding may force the General Assembly to make unforeseen adjustments to affordability assessments.

As always, the MSBA Legislative Office and the MSBA Committee on Laws will monitor all legislation for any potential impact upon the administration of justice and the practice of law. The Committee on Laws will make position recommendations (support, support with amendments, oppose, or monitor) to the MSBA Board of Governors.

There are several key issues of interest to our members. They include:

- Continuation of Bail Reform
- Addressing the Opioid Epidemic in Maryland
- Curtailing Parental Rights of Rapists
- Sexual Assault and Sexual Harassment
- Public Defender Staffing Levels
- Contested Judicial Elections
- Stemming Violence in Baltimore City

In addition, two legislative task forces with MSBA representatives are expected to recommend legislation for 2018 - the Tax Sales Task Force (Michael Cantrell), and the Long-Term Care Educations & Planning Task Force (Morris Klein). The MSBA will play an active role in any legislation resulting from those task forces.

At this stage, it is far too early to make any sort of prediction as to which candidates will emerge as frontrunners going into the June 26, 2018, Primary Election.

#### **Attorney General**

At this point, no candidates have filed. However, Attorney General Brian Frosh is expected to run as a heavy favorite for reelection, unless he should choose to run for Governor instead.

#### Comptroller

Democratic incumbent Peter Franchot has filed for reelection, where he will be challenged on the Republican side by Anjali Reed Phukan, an auditor with the Maryland State Lottery. They are the sole entrants at this point.

#### State Budget

It dawned on me recently that in past years I have devoted too much time in this space to fluctuating State revenue estimates,

possible threats to federal funding, and various other budget worries that I read about in the General Assembly's Spending Affordability Report. I'm willing to bet that if you ask members of the Budget Committees, Senate Budget & Taxation, and House Appropriations (House Ways & Means handles taxation matters in the House), they'll tell you that there's no such thing as a "good" budget year – only varying degrees of bad budget years.

In any case, I did check the latest estimate for the <u>structural</u>

operating budget deficit going into the 2018 legislative session. That figure stands at \$380 million. At least once in the last decade, that figure stood near \$1 billion. So, generally speaking, if you hear that the State has a persistent structural deficit, but that number is under \$500 million, things could be worse.

Additionally, in each Legislative Preview, I try to bring attention to a more obscure aspect of Maryland's budget process that is rarely seen outside of Annapolis. Because not all policy actions come in the form of an actual "garden variety" bill, it's important to be aware of the fact that the General Assembly can issue directives to the Judiciary, or to Executive Branch agencies that do not appear anywhere in the statute.

### Joint Chairmen's Report (JCR)

One of my goals in each year's Legislative Preview is to give the reader a bit of "inside baseball," by explaining some facet of the legislative landscape in Annapolis that even somewhat regular followers of legislation may not know.

Last year I devoted that effort to a brief explanation of the Budget and Reconciliation and Financing Act - The "BRFA" (pronounced 'Burfa'). This year, there are two issues of interest to the legal community that appear in what is known as the Joint Chairmen's\* Report (JCR). The JCR is a document issued by the Chairmen of the Senate Budget & Taxation Committee and the House Appropriations Committee (\*one of these days, the gender designation will disappear), and published by the Department of Legislative Services. The JCR covers every budgetary action, large and small, and gives a brief explanation of every budget cut, or suggested action to either the Executive Branch Agency or the Judiciary.

Below are the two JCR items

expected to take place during 2017 Session budget deliberations, to which I will direct your attention.

#### Item 1. Impact of Bail Rule

During the 2017 General Assembly session, the MSBA's most pressing legislative activity in the area of criminal law was the preservation of the Court of Appeals' newly-crafted Rule 4-216.1, which was to have a delayed effective date of July 1, 2017, instead of new legislation. It is a basic tenet of the MSBA's advocacy in Annapolis that while the legislative and judicial branches share jurisdiction over the court system, there are certain processes of court governance that are best left to the Judiciary.

Please note the concerns of the Budget Committees going forward. Answers to Budget Committee questions and concerns have a strong impact on future actions by the General Assembly. When the General Assembly adjourned in April, their belief that the key indicator of the effectiveness of the new rule would lie in the "failure to appear rate" (FTA) under the new rule. (see the highlighted next-tolast bullet) While I have not seen the Judiciary's formal response on this point, my understanding is that the FTA rate under the new rule is favorable to assessing the effectiveness of the new rule. As a result, the General Assembly may be favorably inclined to allow the rule to stand, and not attempt to displace the rule with new legislation superseding the rule.

Preservation of Rule 4-216.1 will remain a top priority of the MSBA during the 2018 Session.



#### lease Rules:

The committees are interested in the impact of recent changes to the Maryland Rules regarding the pretrial release and the use of cash bail across the State. As the General Assembly continues to consider statutory changes to the pretrial system, it will be especially important to understand the impact of the decreased utilization of cash bail likely to occur under the new rule. Therefore, the committees request a report on the implementation of the new rule from its effective date, July 1, 2017, to September 30, 2017. The report should provide an update on pretrial release practices, including any guidance on the new rule issued by the Judiciary, a preliminary evaluation of the rule's impact on reducing the number of individuals held because they cannot afford to pay their set bail, an explanation of how affordable bail amounts are determined for

individual defendants, and recommendations for General Assembly action that would be beneficial to the implementation of the new rule. In addition, the Judiciary should provide the following data with the report:

- a statewide accounting, by month and jurisdiction, of all pretrial dispositions from July 2016 to September 2017, including the number of defendants, held on cash bail, released without conditions or on recognizance, released with nonmonetary conditions, and held without bail;
- failure to appear rates from July 2016 to September 2017 by jurisdiction: and
- the number and percentage of defendants held in custody more than five days after a bail is set from July 2017 to September 2017."

Item 2. Office of the Public Defender (OPD) – Agency

#### Staffing Levels

There is a widespread notion outside of Annapolis that all the Budget Committees do is go "budget cut crazy." Sometimes it feels that way, but it really isn't true. While the General Assembly can cut from, but can never add money to an Agency's appropriation, there are times when the Budget Committees send notice to the Governor that they believe an Agency is being underfunded in certain areas. In the example below, the Budget Committees are expressing concern that attorneys at OPD are "performing an increasing number of functions that should be performed by non-attorney support staff.

#### 2. Office of the Public Defender Committee Narrative: Attorney Work Functions and Agency Staffing:

The committees are concerned about the impact of support staff shortages in the Office of the Public Defender (OPD) and the potential impact of understaffing on attorney workloads. While the committees are already aware that attorneys perform case related functions that could be assigned to support staff if they were available, including intake, investigations, and general research, the committees would like more information on other support functions attorneys might be required to conduct in understaffed offices. Therefore, the committees request that OPD submit a report detailing any non-managerial, noncase related functions performed by agency attorneys. The report should detail what non-case functions are being performed by attorneys, identify the jurisdictions, and estimate the amount of time attorneys have to devote to non-case functions.



faster than a veto override. In terms of order of procedure, one of the very first Agenda items is Bills Vetoed by the Governor. Governors and their legislative staff go into 'battle stations' mode to preserve In fact, there are few things that a Governor hates more than having a veto overridden by the General Assembly. A veto override by the General Assembly, especially on a high-profile piece of legislation, is regarded by a governor as an act of war, irrespective of whether the Governor is a Republican or a Democrat.

In 2017, after several unsuccessful attempts, the General Assembly passed House Bill 1 - Labor and Employment - Maryland Healthy Working Families Act, otherwise known as that Paid Family Sick Leave bill. The bill passed by "veto-proof" majorities in both the Senate and House. After 90 days of sparring between Governor Hogan and the Democratic leadership, the legislature passed a bill that provided for 5 mandatory paid sick leave days to be provided by employers that have 15 or more employees. The Governor felt that provisions of the bill were unduly burdensome to small businesses. During the Session, the Governor had proposed a 50 employee threshold, but that offer was rejected by the General

On November 27, 2017, Governor Hogan offered to introduce his own "compromise" Paid Family Sick Leave bill as a featured measure in his 2018 legislative package, in exchange for the General Assembly not overriding his veto of the 2017 bill. The Legislative Leadership has signaled that it intends to decline the Governor's offer and proceed with a plan to override his veto of House Bill 1. So, after all the Opening Week greetings and handshakes, the sausage-making will begin.

#### Violence in Baltimore City

As is constantly reported in the news, Baltimore City, in 2017, is having a year of seemingly unprecedented violence. The city has exceeded 300 murders in each of the past three years. Violence in the city has taken its toll on tourism. Aside from murder, other violent crimes, such as carjacking, armed robberies, and aggravated assaults

are on the rise.

The Mayor's Office, the Greater Baltimore Committee, and the Baltimore City Police are expected to work closely with the Baltimore City Delegation and Legislative Leadership to devise new legislative strategies to stem the rising tide of violence, which continues to tarnish Baltimore's reputation, locally and nationally.

#### **Net Neutrality**

Perhaps the fiercest looming battle between the federal government and the states will be over the Trump administration's Federal Communications Commission (FCC) decision to rescind Obamaera rules governing so-called "net neutrality." Net neutrality is the concept that internet service providers (ISPs) are required to give consumers equal access to all online content, and may not create "fast" and "slow" lanes of internet traffic, by way of creating "basic" and "premium" speeds and access to the internet. The FCC is scheduled to vote (at about the time this article will appear) to eliminate the current rule, which the Obama administration instituted in lieu of seeking Congressional statutory

FCC Chairman Ajit Pai recently stated that the rescission of the current net neutrality rule will ensure that "the federal government will stop micromanaging the internet." Pai went on to state that the FCC will go to great lengths to ensure that state and local governments cannot enact their own internet regulatory schemes that run counter to new FCC rules. Several states, most notably New York and California, have expressed an intent to pursue action through the courts (with others likely to follow) if the FCC proceeds with the proposed new rules.

Despite Chairman Pai's pronouncement, the federal preemption with respect to internet governance will prevail, I fully expect that there will be at least a few pieces of legislation introduced during the 2018 session aimed at preserving equal access to the internet for all Maryland residents.

In all likelihood, the widespread state and local opposition to the impending shift in internet

regulation by the FCC is likely to end up in court very quickly.

#### Rape Survivor Family Protection Act

For nearly a decade, legislation has been introduced before the General Assembly which sought to establish a hearing process for terminating the parental rights of rapists. In each instance, the legislation has died. For two of those years, 2015 and 2016, the MSBA opposed the bill on the basis of certain due process concerns. Because the bill did not require a rape conviction or even the filing of criminal charges, the MSBA had concerns about a hearing process that employed a civil preponderance of the evidence standard of proof and did not contain an expressed statute of limitations.

During the summer of 2016, the MSBA worked with the lead Sponsor of the bill, Del. Kathleen Dumais, as well as the sexual assault victims advocacy community, to reach agreement on a revised version of the bill. The MSBA supported the Rape Survivor legislation in 2017, which died in Conference Committee, in the waning hours of the session.

Going into the 2018 Session, Senate President Mike Miller has stated that the Rape Survivor bill will be among his top priorities, which meshes nicely with the support already expressed by House Speaker Michael Busch. Given that level of early support from the Presiding Officers, 2018 should finally be the year of passage for this legislation.

#### **Contested Judicial Elections**

Among the many Constitutional Amendments likely to be introduced this upcoming election year will be measures to eliminate contested elections for circuit court judgeships. For nearly three decades, the MSBA has supported the elimination of contested judicial elections, in favor of a retention election system, such as that which applies to District Court and appellate judges in the State.

#### **Judicial Performance Reviews**

Several recent news articles have highlighted public reaction to undesirable judicial conduct from the bench and led to call for a new, "transparent" evaluation and disciplinary process for judges in Maryland. At least one of the news accounts cited the length of circuit court judicial terms (15 years) and appointed District Court term (10 years) as an added reason for a formal, periodic evaluation system. The most recent article, which appeared in the Baltimore Sun, stated that 17 states and the District of Columbia have systems in place for periodic performance reviews of judges.

The general public is largely unaware of the existence and function of the Commission on Judicial Disabilities (perhaps the name is misleading to most). The same could be said for much of the legislature. The MSBA will closely monitor any legislative discussions concerning judicial performance reviews and work closely with the Maryland Judiciary, partnering in any educational activities that may be developed to address the current awareness gap.

#### **Gun Control**

While the MSBA generally does not become actively involved in matters relating to gun regulation, it is important to address the likelihood of significant legislative activity in 2018 relating to the subject. With two recent mass shootings reigniting the debate over access to certain

types of firearms, who may possess them, and the legality of firearm modifications, the General Assembly is almost certain to revisit this familiar debate.

#### Maryland Assault Weapons Ban

On Monday, November 27, 2017, the U.S. Supreme Court declined to review or comment upon the U.S. Court of Appeals for the 4th Circuit's decision which upheld the constitutionality of Maryland's 2013 law banning military-style assault weapons, and high capacity magazines.

In declining to hear the appeal of the gun-rights advocates, the court did not delve into the merits of the arguments of any of the parties to the appeal.

Now that judicial redress has been forestalled, it is possible that gun-rights advocates may seek legislation to undo the 2013 law. However, recent high-profile, rifle-related mass shootings may lead the advocates to wait until 2019.

#### Mass Shootings

The shootings at the Mandalay Bay Hotel in Las Vegas, and at the First Baptist Church in Sutherland, Texas, and the ensuing news accounts, sparked familiar discussion involving eligibility for gun ownership, personal limits on the number of firearms owned, the shortcoming of gunrelated registries, and what types of modifications to a firearm should be permitted. The Las Vegas incident introduced much of the world to the term "bump stock," a replacement stock that when attached to a semi-automatic rifle, allows the gun to perform more like a fully-automatic rifle. In the Mandalay Bay event, 58 concertgoers were killed, and approximately 500 others were injured. After the Sutherland mass shooting, in which 26 were killed, and 20 others injured, it was determined that the perpetrator should never have been eligible to have purchased the weapons he used in his crimes, based upon his courtmartial and "bad conduct" discharge from the Air Force for assaulting his wife and child. Unfortunately, in this instance, the circumstances of the shooter's discharge were never conveyed from the Air Force to the FBI. Had the information been entered into the FBI background check database, theoretically, he would not have been able to legally purchase the military-style rifle used to carry out his assault on the church.

In reaction to the Las Vegas shooting, which involved a high-powered rifle, modified with a "bump stock," several legislators have expressed interest in banning that rifle modification part in Maryland.

#### Court Decisions: Wrenn v District of Columbia and Matthew Grace and Pink Pistols v. District of Columbia

Additionally, in July 2017, the U.S. Court of Appeals for the District of Columbia invalidated significant provisions of the District of Columbia's handgun law that required a registered owner of a handgun have a "special need" to carry a handgun outside the home. Those provisions are remarkably similar to Maryland's concealed-carry law, so it will be interesting to see if the legislature attempts to forestall court challenge by amending the State's concealed-carry statute.

Historically, the Democratically-controlled General Assembly has been strongly pro-gun control. However, Republican Governor Larry Hogan has been opposed to extending regulation of firearms in Maryland. The Governor has stated that he would vow to uphold laws currently on the books. It will be interesting to see how the political dynamics of any new gun control legislation play out in a gubernatorial election year.

#### Task Force Legislation

The MSBA had representation on two Task Forces that were created by 2017 legislation. On the Task Force on Tax Sales in Maryland, the MSBA was represented by Michael Cantrell, and on the Task Force on Long-Term Care Education and Planning, the MSBA was represented by Morris Klein.

Other Subjects to follow this upcoming year include: Opioid-related education and Treatment Funding; Task Force on Exoneration; Sexual Assault; Sexual Harassment in the Workplace; Judicial Compensation; Attorney's Fees in Cases of Violation of a Constitutional Right; Elective Share; and, Cameras in the Courtroom.

# Being Successful and Feeling Good About Yourself There is No Such Thing as Failure

I often hear from my clients that they have let themselves down or have failed, and don't want to try again because they might fail again. Reframing how we look at "failure" helps us feel better about ourselves and be more successful. If you are afraid to fail, then you might as well give up before you even begin, because the only people who don't make mistakes are those who don't do anything. How you handle mistakes is more important, and it only becomes a "failure" if you stop trying until you succeed. Taking risk and believing in yourself will not only help build your self-esteem, but can also lead

to success in life.

To help you put this in perspective, here are a few extremely successful people who failed before they became successful:

- Walt Disney was fired from the Kansas City Star because his editor felt he "lacked imagination and had no good ideas." He continued to fail several more times before he was successful.
- Oprah Winfrey was publicly fired from her first television job as an anchor in Baltimore for getting "too emotionally invested in her stories."

And the list goes on and on.

Steps To Being Successful And Feeling Good About Yourself

- 1. Ask yourself what you want in life. If you don't ask yourself this question, then you won't know what steps to take to get there. Break it down. Look at short and long-term goals. Come up with steps you need to get there. Do not overwhelm yourself; pick one goal and then determine what is
- **2. Live with intent.** Don't just get caught up in life. Make sure you know why you are doing what you are doing. Actively ask yourself, "Why am I doing this?"
- **3.** See the forest through the trees. Ask yourself, what is the big picture? What are you trying to accomplish? If you know what you want to accomplish, then you

can build a plan and develop steps to help you accomplish your goal. 4. Be gentle with yourself. The former was recorded and will appear in the CLE store soon.

The latter was in partnership with Mockingbird Marketing and Google, and was a wonderful foray into current search engine optimizato build them takes good content, and then requires PR to promote that site.

Make the site mobile friendly. For a complete diagnostic on the speed and mobile readability of a page, put it in the Google website https://testmysite.thinkwithgoogle.com/intl/en-us. Get a report one can act on to fix a specific list of things. Test major competitor pages also, to get the lay of the land.

SSL encryption will soon become necessary and Google will highlight missing certificates in red on search results. Go to https:// Check the robots.txt file on the site to see what the robot spiders see when they scan the website. There should not be duplicate pages. There should be helpful metadata that describes each page to the robots. There should be one title per page. Learn more about robots.txt files and how to test them here: https://support.google.com/webmasters/answer/6062608?hl=en.

Google AdWords are becoming very expensive and many buy wasted ad space. There are two AdWords every firm should bid on though, to protect it: The owner's name and the



tion (SEO), Google AdWords, and ways to generate business. Here is a short list of action items to improve your firm's website performance and get more clients:

Place your NAME, AD-DRESS, and PHONE NUMBER (NAP) in a footer on every page of the website. If the firm has multiple locations, every location should be listed in the footer.

In addition to the standard homepage and contact us page, make a separate webpage for every lawyer in the firm, every practice area, and every location.

A resources page or blog is a good place to have links to other important sites, and invite others to link to this page, establishing yourself as an authority. Those links are very good for SEO rankings, but

letsencrypt.org for a free certificate.

Open a Google search bar and type site:yoursite.com to find out how many pages Google thinks you have. Go through every single one of them to make sure they are legitimate. Get rid of poorly performing pages. This will automatically improve performance of other pages.

If there is something weird in the site:name.com search (a movie being sold in China for example) it means the site has been hacked. Check this even if the site is managed by another and take action if a hack is identified. Google will not send people to a site that has been hacked.

To avoid hacks, use a reputable host. The speakers recommended WP Engine and Flywheel.

law firm name. It should not cost much and if you do not, your competitors may. No one wants to have an ad high in a Google Search that says Don't go to Blank and Blank Firm? We do blank disputes better.

To be successful with Adwords, focus on local searches. 43 percent of clients choose their lawyers based on proximity--they are conveniently located--so bid highest on geographic searches within a mile of the firm location, and less on ones beyond that.

If anyone in your firm is bilingual, capitalize on that advantage. Do website pages that look identical to the English ones, but in the other language. Do AdWords in the other languages. There are few people

## Tech Resolutions

It's that time of year again – a good time to check in with your digital device health and set some new habits to set things right in 2018. 1. Update your critical passwords. It's a good time of year to set new passwords for your most critical online accounts such as banking, email, home WiFi, and social media. Read about strong password habits in this article: go.msba.org/bb1217-1. Document your passwords in a safe place and enable Two-Factor Authentication wherever possible. 2. Reset your smartphone passcode, too. And the default passwords on your network devices. And any other smart devices in your home. 3. Make some space on your devices. Archive your photos and videos from your phone, deleting unnecessary ones first. Consider linking to a Dropbox or Google drive account for easy archiving with plenty of free storage space to get you started.

- 4. Clean up your file folders, especially your desktop, and set a file naming structure for the future. Check out this handy how-to: go.msba.org/bb1217-2.
- 5. Remove any apps from your phone that you are not using with regularity (for example: Candy Crush, Pokemon Go, or whatever other game that was fun for a few days.) Apps that may not be updated or in use could put you at risk, and we all could use more hard drive space for our next operating system update.
- 6. Ensure that your computers and smartphones are regularly backed up and if not, get started! Consider cloud-hosted services from Carbonite, iDrive, Sugar Sync or CrashPlan. Don't get caught without a backup plan! There is nothing worse than being stranded with no back up, and you have far more saved to your home laptop or desktop than you think.
- 7. Ensure that you have antivirus software on your computer systems that is up-to-date and has been scanning regularly. If you don't, look in to packages from Norton or McAfee but choose one! Most computers ship with these programs initially, but may need renewal after a couple years.

8. Review your privacy settings on social media. Platforms change these settings from time to time - make sure your intended audience has remained consistent.

9. Clear your inbox, unsubscribe from sales e-mails you don't need, and set up filters for the coming year based on trends. Check out this article about some inbox tools if you need help: go.msba.org/bb1217-3.

10. Empty your virtual recycle bin: ease up on drive space (and improve those new backup plans) by getting rid of data that you no longer need - like unposted selfies and that digital flyer for your niece's graduation from four years ago. It will feel good to unclutter.

11. Get rid of the physical digital clutter: take devices that are

no longer in use to a recycler. Find an e-cycler or contact your local public works department to find out how to get rid of the printer that's been out of ink since 2009. Yes, you really don't need it anymore.

Bonus: Make a new habit and schedule some non-screen time each day. Utilize app settings so that e-mail and notifications are only received at proper times for you. It's challenging, but quite rewarding - though I often make exceptions to use an e-reader or listen to music. Have a great start to the new year!

# 2018 Family Law Legislative Preview

#### By Lindsay Parvis

On January 10, the Maryland General Assembly begins its 2018 legislative session. The FJLSC's Legislative Committee actively monitors family law and related legislation, testifies in Annapolis, meets with legislators, and educates Section members about legislative developments.

The following is a brief preview of some anticipated family law and related bills in the 2018 legislative session

#### Divorce - Mutual Consent

In the 2015 session, the Legislature enacted a new ground for divorce - Mutual Consent. At present, the Mutual Consent ground (Fam. Law Art., §7-103(8)) is limited to couples who do not have minor children in common. There was an unsuccessful attempt in the 2017 session to eliminate the requirement that both parties appear at the divorce hearing. While this may not be attempted again in 2018, there will be renewed efforts from the 2016 session to expand the ground to all couples. Specifically, to eliminate the requirement that the spouses have no minor children in common. The FJLSC supported eliminating the exclusion of couples with no minor children in common during the 2016 session.

\$7-103(8)(ii)(2)'s reference to \$8-208 regarding use and possession is an artifact of the original draft

(which did not exclude couples with minor children in common), which may result in a corrective bill or may remain if attempts to expand the ground to include couples with minor children succeed.

#### Divorce - Adultery

The 2018 session is expected to see two related pieces of legislation from different sponsors regarding adultery: 1) to decriminalize adultery, so it is no longer a misdemeanor; and, 2) to eliminate it as a ground for divorce. On the one hand, eliminating adultery as a ground would not prevent a spouse from raising the circumstances that contributed to the estrangement of the parties, since these are considerations for a monetary award and alimony. Nor would it prevent a parent from raising adultery in a custody case if it resulted in harm to the child. On the other hand, adultery is one of few grounds for divorce that entitle a spouse to file for immediate divorce (without waiting period) and without separation. Eliminating one ground invites consideration of all the grounds and whether an overall is in order. The FILSC has not taken a position on these anticipated changes and wants to hear from you about this and any other updates you would like to see to the grounds for divorce. Parenting and Custody

The Commission on Child Custody and Decision-Making drafted a model custody statute, which was introduced in substantially similar form in the 2015 session. It was unsuccessful in the 2012, 2016, and 2017 sessions. A version of the model custody statute is expected to be introduced again in the 2018 session, likely updated to reflect recent legislative and caselaw developments regarding third parties and parent disability in custody cases. The FJLSC has supported, and continues to support the model statute.

As ever, legislation proposing a presumption for joint physical and joint legal custody will inevitably be reintroduced this session. The FJLSC continues to oppose a presumption.

#### Marriage

Since 2016, there have been multiple failed attempts by Delegate Vanessa Atterbeary to pass legislation increasing the minimum age to marry in Maryland. The 2017 session saw two such attempts: 1) to increase the minimum age from 15 to 18 years old, with exceptions for 16 and 17 year olds who have parental or guardian consent and meet other qualifications; and, 2) to increase the minimum age from 15 to 18 years old, without exceptions. In 2017, the second of the two passed the House, crossed over to the Senate, passed the Senate with amendments, landing and dying in Conference Committee

without resolving the differences. It is anticipated that these efforts will be renewed in 2018. Increasing the minimum age to marry is important for public policy reasons – because it can be used to conceal human trafficking, domestic violence, child abuse, and statutory rape. But also for legal reasons. Marriage is not an emancipating event. A married minor does not have legal capacity in most instances, including to file suit on his/her own behalf for divorce and protection from domestic violence. A next friend (prioritizing the parents, who under current law likely consented to the marriage) is required. Maryland does not have an emancipation statute, which could address some of these concerns. Opponents to increasing the minimum age to marry to 18 without exception point to minors who wish to marry of age military spouses, and so provide benefits for the spouse and any children. We shall see what the 2018 session brings. The FILSC has not taken a position on this bill and welcomes your input.

#### Emancipation

A proposed emancipation statute is expected this session, likely dovetailing with an increase in the minimum age to marry, even if preserving the right for those under age 18.

#### Domestic Violence

While not specifically a domestic violence bill, the Rape Survivor

Family Protection Act has a long legislative history without passing. Progressing further in the 2017 than any other session – passing both the House and Senate but in different forms - the differences went unreconciled and it died in Conference Committee. This same fate is not likely in the 2018 session with sponsorship announced from both House Speaker Busch and Senate President Miller and ongoing efforts of its tireless proponents. The MSBA supported this legislation in 2017. If passed, the Act would provide an expedited process for terminating rapists' parental rights, so the child can be raised or adopted without the parent's involvement (and interference).

playing in this market, so there is opportunity here.

Another underutilized tool in AdWords is the Call Only button for mobile. Call Only is literally a click button to call the firm, and only costs if the potential client calls. You can turn this ad off when not able and willing to take the call.

Work to make your NAP consistent across the internet. If there are past positions, addresses, or locations out there, start to do the tedious work of correcting the information with those directories and sites. The more inconsistency on address, the more damaging it is to search results for Google, because

Google trades in accurate information and wants people to find you at the location you say you are. (This may be the achilles heal of a virtual law practice.)

Become familiar with Google Analytics and look at it regularly. There should be a steady increase in page traffic over time. If there is not, and the steps above have been taken or there is no time to achieve them, it may be time to hire someone. Call me at the MSBA's Profession and Practice Advancement department for referrals.

Always think about the potential client experience first and foremost. Technology will change and break, so be sure that yours is functioning. Test the site contact page form. Does it go to the right email? Test the firm's voicemail. Does it say We will be back December 26 in June? Test the front desk. Do they bark "Law Offices" as a first impression?

Google representative Lee Regan said Google recognizes from the data that there are five touch points online for potential clients: I want to watch (#1), I want to learn, I want to go, I want to do, and I want to buy. Most just focus on the last one (buying). But see if there are ways your firm can play in the other areas in an engaging and authentic way.

And finally, instead of trying to look like a lawyer that just happens to be a person, try to appear as a person that just happens to be a lawyer. Be true to who you are.

So, while most December articles on practice management are "Tech of 2108" or "Plan for 2018", here are 18 action items to Increase Business for 2018. I do think you should write an annual fee budget (income goal) and plan some business goals, but hopefully this helped with one of them.

eight percent of lawyers are white. Meanwhile, women constitute a third of the profession, but only 17 percent of equity partners.

The Diversity and Inclusion Scholars Initiative will offer financial and professional support every year to approximately 10 academically talented first-year students at Maryland Carey Law.
