Authorizing a parent to petition a court for an emergency hearing to reevaluate a visitation schedule if the other parent fails to comply with a court-ordered visitation schedule without just cause; and requiring and authorizing a court to take certain actions as a result of a parent's failure to comply with a court-ordered visitation schedule.

Summary:

Altering the time period after which a court is required to dismiss a certain charge against a defendant found incompetent to stand trial under certain circumstances; and authorizing a victim or victim's representative to petition the court to extend the time for dismissal of certain charges against a defendant found incompetent to stand trial.
